This Cookie Policy was created by **Limak Doğu Anadolu Çimento Sanayi ve Ticaret A.Ş.** ("**Limak Doğu Anadolu Çimento**") as the data controller within the framework of Article 10 of the Turkish Personal Data Protection Law No. 6698 (the "**Law**") and the Communiqué on the Procedures and Principles to be Followed in Fulfillment of the Obligation to Inform.

Limak Doğu Anadolu Çimento utilizes both first-party and third-party cookies in certain sections of its website, https://www.limakdoguanadolucimento.com (the "Website"). This Cookie Policy (the "Cookie Policy") is applicable to the Website managed by Limak Doğu Anadolu Çimento and the cookies will be used as described in the Cookie Policy.

The purpose of this Cookie Policy is to inform you about the types of cookies used, their purposes, and how you can manage these cookies concerning the processing of personal data obtained automatically through cookies placed on your device by our website. For cookies other than the strictly necessary cookies used on our website, users' explicit consent is obtained, and users are provided with the opportunity to change their preferences regarding their explicit consent at any time.

Users can view the types of cookies used on our website through the cookie management panel and set their preferences as 'active' or 'inactive' for all cookies except strictly necessary cookies. Additionally, users have the opportunity to change their preferences at any time through this panel.

What is a Cookie?

Cookies are small text files created by a website on your device that contain data in a namevalue format. Cookies allow the website you visit to store information on your device and use that information during your subsequent visits. Cookies created by a website are stored by the internet browser you use to access the site, and they do not contain personal data such as names, gender, or addresses of visitors. The information contained in cookies can only be accessed by using the same internet browser and exclusively by the domain of the website that created the relevant cookie, namely, https://www.limakdoguanadolucimento.com.

Cookies have become an integral part of internet technologies today, with their primary functions being to remember the preferences of online visitors and recognize the device during connections. The use of cookies is nearly universal across all websites.

Who Sends Cookies and How?

Cookies are sent through the communication established between your internet browser (*e.g., Chrome, Firefox, Safari, Edge*) on your device and the website servers of **Limak Doğu Anadolu Çimento** while you browse.

Types of Cookies:

- By ownership:
 - First-Party Cookies

These cookies are placed on your device directly by the website you visit or by Limak Doğu Anadolu Çimento.

• Third-Party Cookies

These are cookies placed on your device by third parties, such as those partnering with **Limak Doğu Anadolu Çimento**, which may include advertisers or third-party analytics systems.

- By the duration of active status:
 - Session Cookies

They provide data that can be stored until the user closes the web browser or the session times out. These are temporary cookies.

• Persistent Cookies

These are cookies that remain on the hard drive until they are deleted by the user or until the expiration date specified for those cookies. In their codes, persistent cookies have a specific expiration date that can vary in duration.

• By their intended use:

• Strictly Necessary Cookies

These cookies are required for navigating through the website and utilizing functions such as accessing secure sections of the website.

• Functional Cookies

These cookies remember previously set user preferences (e.g., username, password, language preference) on the website. Preference cookies that enable automatic login to the website are also referred to as functional cookies.

• Statistics Cookies

Statistics cookies, also known as performance cookies, are cookies that provide anonymous, statistical data regarding the use of the website. Statistics cookies can store how the user interacts with the website, including the pages visited and the links clicked. Anonymized statistics cookies are not used to identify the website user. The purpose of these cookies is to improve the website's functionality.

• Advertising and Marketing Cookies

These are cookies that can be used by companies operating to create a profile of your interests and to show relevant advertisements on other websites.

Purposes of Personal Data Processing and Legal Basis

Strictly necessary cookies are used to fulfill the information society services you have requested (e.g., logging in, completing forms, and remembering privacy settings). Your personal data collected through these cookies is processed based on the legal bases specified in Article 5, paragraph 2 (c) *"that the processing of personal data of the parties to a contract is necessary provided it is directly related to the establishment or execution of a contract"* or (f) *"that it is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject"* of the Law.

Advertising and marketing cookies are used by our business partners to create a profile of your interests and show you relevant advertisements accordingly. Your personal data collected through these cookies is processed by obtaining your explicit consent in accordance with Article 5, paragraph 1 of the Law.

Statistics cookies are cookies that enable statistical measurement to analyze user behavior on websites. These cookies are frequently used for improving the website, and this also includes measuring the impact of advertisements on relevant individuals. They are used by website owners to estimate the number of unique visitors, identify the most important search engine keywords leading to a web page, or monitor navigation status on the website. Your personal data collected through these cookies is processed by obtaining your explicit consent in accordance with Article 5, paragraph 1 of the Law.

Functional cookies are used to make our web page more functional and personalized (ensuring that your other preferences, excluding privacy settings, are remembered when you



revisit the website). Your personal data collected through these cookies is processed by obtaining your explicit consent in accordance with Article 5, paragraph 1 of the Law.

Transfer of Personal Data Processed Through Cookies

In addition, if you give consent to the advertising and marketing cookies as well as the statistics cookies specified in the table above, your personal data will be processed on servers located abroad through third-party infrastructure providers based outside the country, limited to the purposes of storage and archiving activities. Within this scope, your personal data will be processed by service providers with servers located abroad, based on your explicit consent, after implementing the necessary technical and organizational measures.

It is not mandatory to use cookies to be able to use our website; however, if you set your browser not to accept cookies, the quality of your user experience may decrease, and various functionalities of our websites may be impaired. In particular, technical cookies ensure that the Website can perform its essential functions. Since technical cookies enable the technical operation of the Website, disabling them may result in some functions on the Website not working properly.
